RE: Traditional Cat Association, Inc.'s Current Governing Body

Dear Traditional Cat Association, Inc.'s Current Governing Body

As you may be aware, this office represents the interests of the Traditional Cat Association, Inc. (TCA). In an effort to help clear up the substantial confusion regarding the governance of TCA, I have been asked to evaluate and summarize the propriety of the steps taken to remove the prior TCA board.

To this end, following is a brief summary of the law governing TCA's existence and procedures, and the steps that were taken within the past several months to remove the prior board.

In March of 1997, TCA was duly re-incorporated in the State of Washington under R.C.W. 24.03, the Washington Nonprofit Corporation Act (WNCA). Such re-incorporation had taken place twice before during TCA's 12-year existence when the TCA headquarters had been relocated to a new state. In each instance, there were no objections raised by the membership, and TCA continued on without interruption, allowing its prior incorporation to lapse and become a shell.

As in most states' corporate statutes, under the WNCA, unless affirmatively displaced by permissible provisions in a nonprofit corporation's constitution, the provisions of this statute govern the administrative activities of all such corporations. In other words, where a provision for a certain action is absent from the bylaws, the statute controls.

SUMMARY OF GOVERNING LAW

REMOVAL OF DIRECTORS: Beyond Impeachment, which is a disciplinary provision, the TCA bylaws do not contain a means by a director may be removed, therefore, WNCA controls. WNCA provides:

> [i]f the articles of incorporation provide for the election of any director or directors by members, then in the absence of any provision regarding removal of directors:

> Any director elected by members may be removed, with or without cause, by two-thirds of the votes cast by members having voting rights with regard to the election of any director ... R.C.W. 24.03.103.

SPECIAL MEETING: The TCA bylaw do not contain a provision for calling special meetings of the general membership, therefore, WNCA controls. Under WNCA:

[s]pecial meetings of the members may be called by the president or by the board of directors. Special meetings of the members may also be called by such other officers or persons or number or proportion of members as may be provided in the articles of incorporation or the bylaws. In the absence of a provision fixing the number or proportion of members entitled to call a meeting, a special meeting of members may be called by members having one-twentieth of the votes entitled to be cast at such meeting. R.C.W. 24.03.075 (emphasis added).

QUORUM (NUMBER REQUIRED FOR A VALID VOTE): "[m]embers holding one-tenth of the votes entitled to be cast represented in person or by proxy shall constitute a quorum." WNCA, R.C.W. 24.03.090.

NOTICE OF MEETING: Pursuant to WNCA, notice of members' meetings, if by mail, is to be posted not fewer than 10, but not more than 50 days before the scheduled meeting. The notice must include the time and purpose of the meeting. R.C.W. 24.03.080.

STEPS TAKEN TO REMOVE PRIOR BOARD

CALL FOR SPECIAL MEETING: Between the 19th and 23rd of July, 1998, 14 members of TCA requested in writing a "special meeting of the members of the Traditional Cat Association, Inc.. At that time, TCA had fewer than 200 members, therefore, the proportion of members requesting the special meeting was greater than one-tenth, exceeding the 1/20th required, thereby constituting a proper call for a special meeting.

NOTICE OF SPECIAL MEETING: On September 24, 1998, a Notice of Members' Meeting was mailed out from the TCA headquarters in Battle Ground, Washington to the entire TCA membership. The notice included the date of the meeting, August 5, 1998, and the purpose as well (see copy attached). This occurred 12 days prior to the date of the special meeting thereby exceeding the 10-day minimum.

SPECIAL MEETING HELD: On August 5, 1998, the Special Meeting Official Ballot was mailed out from the TCA headquarters in Battle Ground, Washington to the entire membership.

RESULTS OF VOTE/QUORUM: Over the next three weeks, 53 ballots completed by members entitled to vote were returned to the TCA headquarter, in Battle Ground, Washington. These ballots were collected and counted by the Heisson Bridge Tax/Accounting Service, in Battle Ground. Of the 53 votes cast, 50 voted to remove the prior board, and 50 voted to elect the new board (see letter attached). Since more than one-quarter of the entire membership voted, the quorum requirement of one-tenth was satisfied.

SUMMARY

Under the Washington Non-profit Corporations Act, directors of such a corporation may be removed with or without cause by vote at a properly noticed and called special meeting of the membership. If those participating in the voting comprise no less than 10 percent of the total membership eligible to vote, and at least two-thirds of those voting vote to remove the board, the board is removed.

By applying the WNCA, the controlling law in this matter, to the steps taken to remove the prior board of TCA, it is clear that TCA removed its board this past August.

I trust that the foregoing analysis has assured you that TCA is a viable non-profit corporation duly incorporated in the State of Washington, and that it now has a newly elected board of directors.

Therefore, all those performing acts within the scope of their duties authorized by the duly incorporated TCA may do so with all the liability limitations provided under the corporate laws of the State of Washington.
