This is notification the CEASE AND DESIST use of any initials of TCA or any reference to TCA as well as any use of TCA Registration numbers IMMEDIATELY. Further more I demand that you remove ALL the TCA initials and Registration numbers from your records, as well as from the CFF registration of Siamese Royalty Windsor's Champion Reg. No. S756M1-118721.
